



## GLOSSARY OF DECEPTIVE TERMS

***The following definitions for the terms listed below are what sexual rights advocates and comprehensive sexuality education (CSE) advocates usually mean when they use these term. These definitions do not necessarily reflect what these terms should mean.***

**Sexual Rights** = A right to any sexual activity or expression including any claimed rights related to contraception, abortion, sexual expression (cross dressing, nudity), LGBT rights, pornography (sale and use of), sexual relations, age of consent, sexual orientation, gender identity (identity papers, hormone therapy, sex-reassignment surgery, etc.), adultery, sodomy, prostitution, use of public facilities, adoption/fertility treatments/wedding services for same-sex couples, sexual education, and more.

*Based on what often happens during UN negotiations and the preoccupation with and emphasis on these alleged “sexual rights,” it appears that these rights are more important to many Member States and UN agencies than any other right—more important than health care, clean water, food, sanitation, housing, education and economic growth.*

**Abstinence Education** = Fear-based, shame-based, unscientific religious instruction on sexuality that denies youth the right to sexual information to protect themselves.

**Age-appropriate** = This is a meaningless term designed to trick people into accepting CSE. Their philosophy is that there is no age limit to the right to sexual information and activity as long as it is consensual.

**Comprehensive Sexual and Reproductive Health Services** = Encompasses any and all services related to “Sexual Rights” listed above.

**Comprehensive Sexuality Education (CSE)** = Indoctrination on gender ideology, homosexuality, abortion, promiscuity, masturbation, radical feminism and sexual rights that is designed to sexualize children and turn them into sexual rights activists.

**Confidentiality and Privacy** = Information and services, especially of a sexual nature, without the knowledge or consent of parents.

**Consent:** Asking someone for sexual favors regardless of age.

**Culturally Appropriate** = Advances respect for and rights of LGBT people.

**Diversity** = LGBTQI inclusive.

**Evidence-Based** = Sexuality education (cannot include abstinence) and that is backed by biased studies done by CSE advocates.

**Forced Pregnancy** = Forcing a woman to remain pregnant by not providing an abortion.

**Gender** = Male and female plus over 112 additional genders recognized on Facebook.

**Gender Equality** = Equality between men and women and boys and girls, but also equality between homosexuals and heterosexuals, and transgenders and cisgenders with regard to the “Sexual Rights” listed above.

**LGBTQI** = Lesbian, Gay, Bisexual, Transgender, Queer or Questioning, and Intersex.

**Health Rights** = Any claimed “sexual rights” listed above.

**Human Rights** = Any claimed “sexual rights” listed above.

**Human Rights Defenders** = Anyone who advocates for abortion, LGBT and prostitution rights.

**Inclusive** = Embracing homosexuality, promiscuity and transgenderism, etc.

**“Men Who Have Sex with Men” (MSM)** = Men who engage in sodomy, who may or may not identify as homosexual.

**Reproductive Rights** = Abortion rights and rights for same-sex couples to access reproductive technologies such as surrogacy, in-vitro fertilization, and adoption of children. (See [ReproductiveRights.org](http://ReproductiveRights.org))

**Reproductive Health** = Abortion (see Hillary Clinton’s Congressional testimony) and transgender sex-reassignment surgeries.

**Reproductive Health Services** = Contraception and abortion services.

**Right to Education** = Right to comprehensive sexuality education including the right to all forms of sexual information and services listed above including pornography. (See report on Special Rapporteur on the Right to Education.)

**Right to Sexual Health** = Rights relating to LGBT sex and expression. The right to comprehensive sexuality education.

**Rights** = An all-encompassing term that can include all “sexual rights” listed above depending on the context.

**Rights-Based Approach** = An undefined, vague, overly broad term that means an LGBT and abortion rights-based approach.

**Sex Work** = Prostitution.

**Sexual Health** = The health of individuals based on their realization of all the claimed “sexual rights” listed above.

**Sexual and Reproductive Health and Rights** = All rights claimed under “sexual rights” listed above.

**Sexuality** = The World Health Organization (WHO) “Working Definition” for “Sexuality”: Sexuality encompasses gender identities and roles, Sexual orientation, Eroticism, Desires, Pleasure, Attitudes, Fantasies, Behaviours, Roles and Relationships (Source: WHO, 2006)

**Women’s Rights** = Abortion rights.

**Youth-led/Youth Participation** = Organizations led by youth trained in LGBT rights usually facilitated by Planned Parenthood or UNFPA.
