

When do boys become fertile, testing sperm motility?



















What The Kinsey Team Claimed

4,441 Female Subjects & No Rape!!!???



To: June M. Reinisch From: Paul Gebhard Date: December 6, 1930

In your recent letter of December 3, which I gather was sent to a number of individuals as well as to me, you refuted Judith Reisman's allegations about kinsey and the Institute. However I fear that your final paragraph on page 1 may embarrass you and the university if it comes to Reisman's attention. Hence I want to warn you and relevant university officials so that some damage control might be devised. The paragraph ends with this sentence: "He never used data from the special samples, derived from such populations as the gay community or prisons, to generalize to the general public."

This statement is incorrect. Kinsey did mix male prison inmates in with his sample used in Sexual Rehavior in the Human Male. I describe this defect at the bottom of page 28 of The Kinsey Data and add that Kinsey later recognized this error and hence did not use prison inmates in Sexual Behavior in the Human Female. This inclusion of prison inmates was a major reason why on page 35 of The Kinsey Data I state the samplewas misleading with respect to the lower socio-economic class. The excellent college educated sample contained almost no one with prison experience.

As to generalizing to a wider population, in his first volume Kinsey did generalize to the entire U.S. population. See, for one example, the tables on page 188 and 220 where he clearly extrapolates to the U.S. Subsequently he realized this error and no such extrapolation is found in his second volume.

I am distressed that neither you nor your staff seem to be familiar with Kinsey's first book nor with The Kinsey Data and consequently produced the erroneous statement in your letter.


Kinsey's Kronhausens: America's 1960's Joe College was an unapologetic "virgin"







Kinsey Reports (KR): The Advent of "Consent"

KR falsely claims that 95% of white men would be sex offenders. were the common law enforced:

- 69% frequent prostitutes (prostitution is illegal)
- 85% have pre-marital sex (fornication is illegal)
- 50% commit adultery (adultery is illegal)
- 10%-37% are somewhat homosexual (sodomy is illegal)

While of white women KR falsely claims that:

- 0% are harmed by rape 50% have pre-marital sex (fornication is illegal)
- 26% commit and 50% desire adultery (adultery is illegal)
- 87% of pregnant single women abort (abortion is illegal)
- 25% of wives abort (illegal)

Of children, KR falsely claims that 100% are orgasmic from birth, hence:

- Children can benefit from sex with adults and older persons. even incest (illegal)
- Children need early, explicit school sex education (illegal)
- Children need masturbation, hetero/homosexual acts taught (illegal)

Of parole, KR falsely claims that sex offenders rarely repeat sex crimes.

1955 MPC: Rape of 10 yr. olds

If a "victim" had previously engaged in promiscuous sexual activity...A [10 yr, old] ... accustomed to sexual activity (1) would suffer little or no psychical harm ... and (2) might well be the seducer rather than the seduced."

Even at the age of four or five, [her] seductiveness may ... overwhelm the adult into committing the offense."

This research was approximed by Office of Juvenile Justice and Delinquency Prevention (OJJDP), United States Department of Justice, Project No. 84-JN-AX-K007, and carried out at The American University, Washington, DC, from February 1984 to November 1985 and delivered to OJJDP in November 1987. Principal Investigator was Judith A. Reisman, Ph.D.

While the complete three-volume Reisman Report is available from OJJDP, the agency shelves several drafts of various reports ostensibly written by Dr. Reisman. However, only the November 1987 Reisman Report has been approved by the Peer Review Board and authenticated by the Principal Investigator. The Overview, Volume I, is recommended as a brief (503 page) synopsis of the research project and relevant information. All three volumes total nearly 2,000 pages. 1945-1986: "NYT Index" Press Headings of "New" Sex Crimes






Introduction

It is my pleasure as former National Chair of ALEC, to introduce this State Factor, "Restoring Legal Protections for Women and Children: A Historical Analysis of the States Criminal Codes," proposed during my chairmanship and then approved December 11, 2003 for publication by the ALEC Education Task Force. The Education Subcommittee on Junk Science in the Classroom, ably chaired by Kansas Senator Kay O'Connor, commissioned this research because of widespread use of "junk" science misdirecting legislatures, courts and education.

The evidence presented in this State Factor reveals compelling evidence of illegal and criminal acts masquerading as science taken from Kinsey's confessions in his own "Reports" (1948-1953). Dr. Alfred Kinsey was a "sexual revolutionary" and his "Kinsey Reports" are junk science. Professor of Constitutional law Dr. Charles Rice of Notre Dame concluded that Alfred Kinsey's research was:

"...contrived, ideologically driven and misleading. Any judge, legislator or other public official who gives credence to that research is guilty of malpractice and dereliction of duty."

Since World War II Kinsey's fraudulent data informed and directed the American Law Institute's "Model Penal Code" in eliminating and weakening 52 sex laws that once protected marriage. If indeed, as Justice Brandeis once said, "law points the way," the changes to public policies and law naturally followed

the Kinsey junk science sexuality model. The ALI's penal law reforms recommended to legislators and lawyers were largely adopted between 1960 – 1980 and permitted Kinsey's abnormal sexual conduct to be taught to American children via sex education. Since then public health costs from sexual disease and dysfunction have skyrocketed indeed all measures of socio sexual disorder have soared from the 1960s, when protective laws began to be weakened and/or eliminated.

As Kinsey intended, contemplated in the current debate are calls for "discrimination" laws to protect the full range of sexual activities including transvestitism, transgenderism, polygamy, bestiality and the like and, in education, whether to teach our children all "alternate" sexual acts as normal - or to teach Chastity and Abstinence until marriage.

This State Factor is a valuable reference and resource for your work in government, because it provides you with history and current information of the utmost importance for any informed understanding of many public issues crucial to the protection of America's families and young people. Understanding how junk sex science has deformed our thinking and laws is vital as legislators "point the way." Restoration of reliable and honest standards in our state laws will ensure more healthful and economically sound outcomes for generations to come. Only if enough legislators call attention to Kinsey's questionable findings, can we start to reverse the misguided assault on American law and way of life through investigation, inquiries



el Penal Code: Obscenity OK in Schools, Libra

 43 states, including Indiana, have adopted the MPC exemptions for providing obscene/indecent materials to children if the materials are used by "educators" and/or for "educational" purposes, as part of courses of instruction and/or in libraries in K-12 schools and in public libraries.

 Therefore, in these states, a person providing obscene/indecent materials to a child faces fines and jail time for "harming" the child, EXCEPT when the person is a teacher, librarian, lecturer, consultant, etc. providing the materials in an "educational" context!

Indiana's Exemption for schools and libraries

Ind. Code § 35-49-3-4 Defense to prosecution for dissemination of matter or conducting performance harmful to minors (Exemptions)

Sec. 4. (a) It is a defense to a prosecution under section 3 of this chapter for the defendant to show:

- (1) that the matter was disseminated or that the performance was performed for legitimate scientific or educational purposes;
- that the matter was disseminated or displayed to or that the performance was performed before the recipient by a bona fide school, museum, or public library that qualifies for certain property tax exemptions under IC 6-1.1-10, or by an employee of such a school, museum, or public library acting within the scope of the employee's employment;
