





This is because unlike traditional sex education, comprehensive sexuality education is highly explicit and promotes promiscuity and high-risk sexual behaviors to children as healthy and normal. CSE programs have an almost obsessive focus on teaching children how to obtain sexual pleasure in various ways. #### II. ARIZONA SEX EDUCATION FEDERAL FUNDING PROFILE

Federal Government Programs and Grants Awarded for Arizona

WARNING: While grant requirements may state that curricula/programs are to be "evidence based" or "medically accurate" in order to receive funding, research shows that, often, funds go to curricula/programs that are ineffective (See SexEdReport.org). In addition, content analyses show that many programs (Link to harmful CSE elements chart) normalize teen sex, encourage sexual pleasure-seeking, condone early sexual debut and promote high-risk sexual behaviors. It is important to look at the actual content of every curricula rather than relying on labels assigned to them.

**DASH—Division of Adolescent and School Health,** a division of the Centers for Disease Prevention (CDC), works with community partners to provide training and resource development for so-called "HIV, STD, and pregnancy prevention" programs in school-based and community settings.

Arizona received DASH funds totaling \$80,000 in fiscal year 2016.

**PREP**—The **Personal Responsibility Education Programs**, under the Family and Youth Services Bureau (FYSB), provides grants for sex education programs that are sometimes called "abstinence plus" programs and that focus on "both abstinence and contraception."

Arizona received PREP funds totaling \$1,050,744 in fiscal year 2017.

**SRAE**—**Sexual Risk Avoidance Education** grants go to curricula/programs that emphasize risk avoidance and teach youth to voluntarily refrain from non-marital sexual activity and other risky behaviors. Note: See warning above.

Arizona received \$440,317 program funding in 2016.

Title V—The TITLE V State Abstinence Education Grant Program funds abstinence education and mentoring to promote abstinence. However, note that at least one Title V program promotes promiscuity as healthy and normal. As noted above, it is important to look at the actual content of the curricula.

• Arizona received a Title V award totaling \$1,756,349 fiscal year 2017.

**TPP**—The **Teen Pregnancy Prevention** program, through the Office of Adolescent Health (OAH), funds comprehensive sex education programs for children aged 10 to 19.





#### III. FEDERALLY FUNDED SEX EDUCATION PROGRAMS IN ARIZONA

Note: Programs in <u>red</u> text have been analyzed and found to contain harmful content for children. Programs not in red may or may not have harmful content.

For example, the analysis of <a href="Making a Difference">Making a Difference</a>, shows CSE programs sexualize children and encourage promiscuity and risky sexual behavior, typically without providing medically accurate information about the long-term risks associated with early sexual debut and experimentation.

#### IV. OVERVIEW OF ARIZONA SEX EDUCATION LEGISLATION & GUIDELINES

The following laws and guidelines apply to sex education and how sex education is taught in Arizona.

According to 2018 Arizona Rev. Statute Title 15

#### Sexual Education Requirement (15-711)iii

- Sexual Education is not required.
- All school districts with existing sex education curricula shall include instruction on the laws
  relating to sexual conduct with a minor for pupils in grades seven, eight, nine, ten, eleven and
  twelve. Each school district may develop its own course of study to meet the requirements of
  this section

#### Parental Involvement (15-102)iv

- Procedures must be put into place for Parents to have:
  - A right to consult with teachers and administrators to develop and adopt policy for parent involvement.
  - A right to learn about the course of study for their children and review learning materials including the source of any supplemental educational materials.
  - A right to object to any learning material or activity that may be harmful and may
    withdraw their children from the class, program or activity. Harmful includes objection
    to material or activity because it questions beliefs or practices in sex, morality or
    religion.
  - School cannot provide sex education to a pupil without a parent's written permission for the child to participate.
  - A right to be notified in advance and given a chance to withdraw their children from any instruction or presentations regarding sexuality in courses other than formal sex education.
  - A right to learn about the nature and purpose of clubs, curriculum, extracurricular activities that have been approved by the school.
  - Public educational institution shall obtain signed, written consent from a students' parent before using video, audio or electronic materials that may be inappropriate for the age of the student.

#### Parents have a right to:

- Opt in to a sex education curriculum if one is provided
- · Opt out of assignments related to sex education
- Opt out of instruction on the acquired immune deficiency syndrome
- Public review of courses of study and textbooks related to sex education
- Inspect the school district policies and curriculum
- Review learning material and activities in advance. If parent objects to materials, classes, activities or programs on a basis that the material is harmful, they may withdraw student and request an alternative assignment. (15-113)



Age of Majority =

Based on Arizona law, anyone under the age of 18 is considered a minor, while those 18 years old and older are considered adults. vi

#### Age of Consent =

In Arizona, the age when children can legally consent or agree to sex is 18.vii



#### V. PARENTAL RIGHTS AT RISK IN ARIZONA

Warning! Most CSE programs put parental rights at risk by either encouraging or requiring that parents not be notified and/or by instructing children how to access such things as abortion, contraception and other so-called health services without parental notification or consent.

It is particularly dangerous to encourage students in this way, particularly considering the fact the laws often support what is being taught in CSE programs. For example:

Without notifying or receiving consent from their parents, minor children in Arizona may consent to and receive:

- All contraceptive services
- All STI (sexually transmitted infection) services

In Arizona, parental consent is required for:

Abortion services



# HARMFUL CSE ELEMENTS 1. SEXUALIZES CHILDREN Normalizes child sex or desensitizes children to sexual things. May give examples of children having sex or imply many of their peers are sexually active. May glamorize sex, use graphic materials, teach explicit sexual vocabulary, or encourage discussion of sexual experiences, attractions, fantasies or desires.

#### 2. TEACHES CHILDREN TO CONSENT TO SEX

May teach children how to negotiate sexual encounters or how to ask for or get "consent" from other children to engage in sexual acts with them.

Note: "Consent" is often taught under the banner of sexual abuse prevention. While this may be appropriate for adults, children of minor age should never be encouraged to "consent" to sex. **Note:** While all the above may be true, is it the role of government to be teaching school-aged children about sexual desire?

**Note:** While coercion and forced sex are highly inappropriate and should never condoned, these lessons and instruction regarding affirmative consent, go far beyond teaching children how to protect themselves and say "no" to sex. Instead, children are taught—at the young age of 14 and 15—to consider the type of sexual activities they desire and to learn how to ask for those things.

"Today we will begin looking at what it means to give truly free and informed consent in a situation involving sex." (Vol. 2, pg. 76)

"Plan time to discuss sexual consent in a meaningful way. Many young people feel ambivalent about what they want or confused about their partner's wishes. Explore ways to ensure mutual consent." (Vol. 1, pg. 81)

"A critical aspect of sexual experience is that it be voluntary and wanted by both partners. ... • Sexual consent involves deciding freely and voluntarily to engage in sexual activity with another person. • ... ensuring consent can be a complicated matter. • As young people mature, their capacity to give meaningful consent evolves." (Vol. 1, pg. 85)

#### 3. PROMOTES ANAL AND ORAL SEX

Normalizes these high-risk sexual behaviors and may omit vital medical facts, such as the extremely high STI infection rates (i.e., HIV and HPV) and the oral and anal cancer rates of these high-risk sex acts.

"Students examine the indicators of maturity, self-awareness, self-efficacy, and ability to communicate that are part of what a young person needs to negotiate a safe and comfortable sexual relationship." (Vol. 2, p. 92-95)

Who can remember a time when you were unsure how to express your desires or wishes clearly? [Notice whether girls or boys are more likely to respond to this question.] (Vol. 2, p. 113)

**Note:** Anal and oral sex are described and then condoned as just part of a range of sexual activities, with examples being given of girls and boys who engage in these activities. Only limited information is given about the associated health risks.

"Sexual intercourse often refers to vaginal penetration by the penis. **Oral intercourse** involves the mouth at or on a partner's sex organ. **Anal intercourse involves** insertion of the penis into a partner's anus." (Vol. 1, pg. 112)

"Grace, who also had a bit to drink, lies down next to him. Feeling uninhibited, she takes the initiative and has oral sex with him." (Vol. 1, pg. 75)

"Oral sex can result in the transmission of various STIs, including HIV. • For some STIs, girls are physiologically more vulnerable to infection than boys. Receptive anal intercourse increases risk of infection (for boys and girls). Social factors also affect the likelihood of transmission ...People who are sexually active can take steps to reduce their risk of acquiring an STI." (Vol. 1, pg. 189)

"HIV is transmitted not only through vaginal or anal sex between a man and a woman; it can also be transmitted through anal sex between two men. Having a sexually transmitted infection can increase the risk of acquiring or passing HIV during sex." (Vol. 1, pg. 258)

It's All One Curriculum" is the premier comprehensive sexuality education (CSE) program promoted by UN agencies as the model for all other CSE programs. In fact, UNESCO partnered with Planned Parenthood to create a CSE analysis tool that uses the content of "It's All One" as the standard against which they claim all other CSE programs should be judged. This is very troubling in light of the fact that "It's All One" scored 15 out of 15 on harmful content for children (see below). For example, "It's All One" promotes promiscuity, teaches children about "sexual pleasure" (60 references) and promotes abortion (with over 1000 references) and is really just a cleverly disguised abortion rights, sexual rights, sexual pleasure advocacy education program.

Funded in part by UNFPA and International Planned Parenthood Federation (IPPF), *It's All One* has been translated into Spanish, French, Bangla, Chinese, and Arabic, and its developers claim that requests for *It's All One* have come from more than 150 countries and every state in the United States.

It's All One exposes children and youth to multiple harmful concepts, through statements and various activities, such as role plays, games, and videos that are harmful and sexually engaging to children.

It's All One Curriculum contains 15 of the 15 harmful elements typically found in CSE curricula or materials. The presence of even one of these elements indicates that the analyzed materials are inappropriate for children. Having several of these elements should disqualify such materials for use with children.

Program Description: The It's All One Curriculum is a prime example of how multiple manipulative tactics are used to indoctrinate and sexualize children through CSE. It has been promoted by UNESCO and UNFPA as a premiere model for sexuality education and claims to be based on the strategies established by the UN General Assembly, UNAIDS, the World Health Organization, UNESCO and the World Association for World Health.

Like other CSE programs, It's All One falsely claims, among other things, to be evidence-based, comprehensive, gender sensitive and culturally appropriate education, that will increase young' people's responsible decision making and, will ultimately reduce adolescent rates of pregnancy and sexually transmitted infections, including HIV.

However, as the analysis below reveals, It's All One:

- · Indoctrinates youth in radical feminist ideologies regarding power, privilege, and equality.
- Aggressively promotes abortion with over 140 references to abortion, manipulating young minds using scare tactics
  to suggest pregnancy is more dangerous than abortion and stories that seem to prove that abortions are harmless,
  even desirable, even for young girls.
- · Has an obsessive focus on sexual pleasure, with sexual pleasure being mentioned over 70 times.
- Promotes multiple sex acts—with both opposite-sex and same-sex couples.
- Encourages students to become sexually active, telling them that "there is no right age to have sex" and that each
  person can determine when he or she "feels ready."
- Undermines parental guidance and societal norms, by encouraging youth to question traditional cultural values, instead of advocating for tolerance and protection of dangerous sexual practices.



#### Evidence of Failure

There is no evidence that It's All One is an effective curriculum for reducing risky sexual behavior among young people.

A common tactic used by comprehensive sex education (CSE) advocates is to claim their programs are "evidence-based," asserting they are backed by studies that prove their effectiveness for young people. However, the research does not support this view, according to a recent in-depth review of some of the strongest and most current studies of CSE in school settings. (See SexEdReport.org.) This extensive analysis reviewed 60 studies of 40 school-based CSE programs in the United States and 43 studies of 39 school-based CSE programs used outside of the U.S. (all studies were previously vetted for research quality by HHS, the CDC, or UNESCO.)

Applying meaningful and recommended standards to assess program effects on increased teen abstinence and/or condom use and decreased teen pregnancy or STDs, the researchers found little evidence of real effectiveness for school-based CSE and a concerning number of harmful effects. Out of the 103 studies, only 10 showed improvement on a key protective indicator one year after the program, for the intended population, without other negative effects. Yet, 15 of these studies found school-based CSE programs had a harmful impact – by increasing teens' sexual risk behavior and/or reducing their sexual health.






